Mental Health Nurse, (O-4, non-supervisory).

### \*\*\* JOB DESCRIPTION\*\*\*

Specific duties and responsibilities include, but are not limited to the following:

As a member of the Mental Health Team, the Mental Health Care Coordinator (MHCC) provides interdisciplinary care coordination for patients seen in the mental health clinic (MHC) and acts as the primary liaison to other interdisciplinary teams providing care to patients seen in the MHC with a focus on coordination with primary care teams. The MHCC provides comprehensive care coordination and performs as directed MH case management functions, IAW AFI 44-172, *Mental Health*, for patients identified as high risk, complex, or in transitions of care and oversees all patient care coordination activities within the MHC by other members of the team. Care coordination is a deliberate cross-cutting action that involves high-quality, caring, and well-informed staff, patients and caregivers, to include command as appropriate, who must work together across health and social care settings to support the patient. Coordination involves efficient use of systems and services that both communicate and identify barriers in the continuum of care within the internal care system and external providers and facilities.

The MHCC provides professional nursing services as related to triage of patient care needs, assessment of new patients, proactive care management to include medication compliance and patient/family education. The MHCC participates and/or leads staff meetings and leads/assists quality improvement activities focusing on improving care coordination processes and functions. Additional roles may include: Mental Health Clinic Staff Education and Training Officer, Suicide Prevention Program Manager, Director of Psychological Health, and Mental Health Case Manager (MHCM). They may also serve as the Behavioral Health Team Resilient Airman Counsel (RAC) and/or Integrated Delivery System (IDS) representative.

### CONDITIONS OF EMPLOYMENT:

Working knowledge and a minimum of three years of experience with levels of care to include post hospital and acute care illness stabilization. Be able to anticipate and articulate to health management and/or interdisciplinary team, the patient's needs, requirements, abilities, and limitations.

A minimum of three years of experience with professional nursing care standards, theories, principles, practices, disease process and procedures to perform nursing assignments of moderate to severe difficulty and experience to acutely and chronically ill adult and geriatric patients as appropriate.

Must possess a working knowledge of computer operations and demonstrates proficiency in the use of basic word processing, data entry and Electronic Medical Records and/or Electronic Health Record.

Must have at least 36 months of total nursing experience in a direct patient care clinical setting (Dual AFSC 46N3/M46P3 experience preferred). Must have experience providing services such as psychiatric nursing or behavioral health and wellness counseling within 24 recent consecutive months.

**Certification:** Certified/certification eligible by the American Nurses Credentialing Center (ANCC) as a Psychiatric and Mental health Nurse with 2 years full time Experience in mental health.
